


Terms & Condition

High School Road, P.O./Dist: Boudh – 762014", the category for which Quotation is submitted is to be super-scribed on the body of the sealed cover and should reach the undersigned through Speed Post/Courier/Regd. Post with A.D. only. The last date of submission of quotation is 05.08.2025 up to 12.00 noon. The authority will not be responsible for any postal delay. The quotations will not be received after scheduled date and time.
3. The unit price quoted against the items should be inclusive of GST, packing, forwarding, transit & any other charges. All deliveries must be made to our Head Office at Boudh free of charges.
4. All finished goods must strictly adhere to the provided specifications. If any deviations are found, the Bank reserves the right to reject the goods. In such cases, the supplier must retrieve the rejected goods at their own expense and deliver replacements that meet the specifications within 10 days. Failure to comply will result in the Bank taking necessary action against the supplier, which may include blacklisting them for a period of three years.
