



Post with A.D. only. The last date of submission of quotation is 10.06.2026 on 12.00 noon. The authority will not be responsible for any postal delay. The quotations will not be received after scheduled date and time.
3. The unit price quoted against the items should be inclusive of GST, packing, forwarding, transit & any other charges. All deliveries must be made to our Head Office at Boudh free of charges.
4. All finished goods must strictly adhere to the provided specifications. If any deviations are found, the Bank reserves the right to reject the goods.
